RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ERIE COUNTY, OHIO, FOR THE PURPOSE OF APPROVING AND LEVYING ASSESSMENTS FOR THE KELLEYS ISLAND AIRPORT DRAINAGE IMPROVEMENT, DITCH #139, ERIE COUNTY, OHIO

The Board of County Commissioners of Erie County, Ohio, met this 2nd day of September, 2020 in regular session with the following members present:

Patrick J. Shenigo, Mathew R. Old, and Stephen L. Shoffner.

Mr. Old introduced the following resolution and moved its adoption.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ERIE COUNTY, OHIO:

THAT, the assessments previously confirmed, including the cost of location, engineering, compensation, damages, and contingency and the assessment for maintenance of one year are hereby levied upon said parcel of land, each public corporation and each department, office, or institution of the State, as stated in the schedules for the Kelleys Island Airport Drainage Improvement, Ditch #139, as of the date of this order; and

THAT, the County Auditor is hereby directed to notify the owners of all assessed lands of the amount of the actual assessment and of the payment plan for the collection of the assessment; and

THAT, the assessments shall be collected in one payment within 30 days or placed on the first tax duplicate to be collected in full and deposited in the Kelleys Island Airport Drainage Improvement, Ditch #139 Construction Assessment Account; and

THAT, the County Auditor is hereby directed to immediately place the assessments so levied upon the duplicates of the County, making and furnishing the Treasurer of said County a special duplicate with the assessment arranged thereon in semi-annual installments, not to exceed twenty (20). If any such assessment is \$25.00 or less, the same shall be paid in full in one payment; and

THAT, this Board of County Commissioners hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board; and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code.

Mr. Shoffner seconded the motion for the adoption of said resolution; and the roll being called upon its adoption, the vote resulted as follows:
